Class registration fees:

- 6-week Manners and Control Class: Non-Member is \$100, Half price for Members and repeat Students.
- Drop-in classes for Obedience and Conformation training is \$15, Member is \$10.

Training Facility Operating Policies:

1. Classes will be paid for at the time of advanced registration to hold a spot in class.
2. No refunds or make-up classes will be given after the class has started.
3. In Obedience there is a limit of one dog per person per class.
4. In Confirmation there is a limit of two dogs per person per class.
5. Dogs must always be on a leash when on the property.
6. Vehicles must be parked where they will not interfere with the entrance of other dogs into the building.
7. The training director or a designated instructor reserves the right to expel dogs from the facility that show aggression towards people or other animals.
8. Do not allow dogs to meet in class until the instructor gives permission.
9. If your dog is sick. DO NOT bring them to class.
10. Your dog is expected to show ready for exam (Hygiene) at each training class and be free of parasites.
11. Please clean up after your dog. Supplies are on hand for cleaning.
12. Young children must be supervised by an additional adult so the primary handler of the dog can devote their full attention to class.
13. Dogs in heat are not allowed in class.
14. All vaccinations need to be up to date with proof of shot record at registration (Rabies and DHLPP).
15. CTKC, training director or designated instructor, reserves the right to expel any dog owner that does not follow these policies from the class with no refund.

Waiver of Liability and Informed consent Release

I, the undersigned, have enrolled myself and my dog in dog training classes, private consultations workshops or other related activities (classes) offered by the Cen-Tex Kennel Club, Inc.

By signing hereunder, I certify that I have been informed and understand that there is always some unavoidable risk of injury involved when working with animals, especially animals with behavioral issues. I acknowledge that dogs can be inherently difficult to control and not all dogs will always be under control resulting in the possibility of injury to myself, my dog, my family members, or third parties. Additionally, I have had full opportunity to discuss all concerns I have about the forgoing risks with Cen-Tex Kennel Club Inc. and its authorized representatives. I have also made all inquiries and investigations to my satisfaction related to such risks, including, but not limited to an examination of the training area.

I hereby accept and assume, without reservation, all risks associated with my participation in the classes including, but not limited to: the risks of any and all injuries to myself, my dog and any of my family members or third parties who may attend; the risks that my dog may cause injury to other persons or dogs involved in the classes: and the risks that saliva, water, food, show and/or other debris may be present in the training area. I have read and understand Cen-Tex Kennel Club Training Facility Operating Policies and agree to abide by them to the extent applicable.

As lawful consideration for participating in the classes I for myself, my heirs, executors' administrators, legal representatives, successors and assigns (the "Releasing Party") hereby waive, release, discharge and agree not to sue and to indemnify, defend and hold harmless Cen-Tex Kennel Club Inc. and their members, club officers, board members and agents (the "Released Party") from any and all injuries, losses, claims and damages to any person or persons of any nature whatsoever, including claims arising from the Released parties own negligence, and all costs associated therewith, including attorney's fees, court cost and consultant fees, arising from my participation in the classes.'

This Waiver of Liability an informed consent relapse shall be legally binding on the Releasing Party. Should the releasing party assert a clam contrary to what I have agreed to in this waiver of liability and informed consent release, the claiming party shall be liable for all expenses (including attorneys fee, court cost and consultant fees) incurred by both the releasing party and the Released Party. No waiver or modification of any provision herein shall be valid unless expressly agreed to in writing by both the Released Party and the Releasing party.

I hereby consent to my dog being subject of the photographs and/or audio-visual recording and authorize Cen-Tex Kennel Club Inc. and its agents to cause the same to be exhibited for educational purposes as still photographs, transparencies, motion pictures, television, video or other similar media. I hereby release Cen-Tex Kennel Club Inc and agent from all claims for damages for libel, slander, invasion of privacy and other claim based on use of the above-described materials.

Every provision herein is intended to be severable. If any one or more other provision here is to be found unenforceable or invalid that shall not affect the other terms and provisions hereof, which shall remain binding enforceable.
